


INDEPENDENT PRACTITIONER'S REVIEW ENGAGEMENT REPORT

To the Members of Farkas for Calgary Campaign

We have reviewed the accompanying Campaign Disclosure Statement and Financial Statement (Form 26) of Farkas for Calgary Campaign (the organization) for the 2025 campaign period ending July 31, 2025, interim report, that comprise Form 26, Contributor list, the campaign expense report and a summary of significant accounting policies and other explanatory information.

Management's Responsibility for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with the Local Authorities Election Act (LAEA), and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

Practitioner's Responsibility

Our responsibility is to express a conclusion on the accompanying financial statements based on our review. We conducted our review in accordance with the Canadian generally accepted standards for review engagements, which require us to comply with relevant ethical requirements.

A review of financial statements in accordance with Canadian generally accepted standards for review engagements is a limited assurance engagement. The practitioner performs procedures, primarily consisting of making inquiries of management and others within the entity, as appropriate, and applying analytical procedures, and evaluates the evidence obtained.

The procedures performed in a review are substantially less in extent than, and vary in nature from, those performed in an audit conducted in accordance with Canadian generally accepted auditing standards. Accordingly, we do not express an audit opinion on these financial statements.

Conclusion

Based on our review, nothing has come to our attention that causes us to believe that the financial statements do not present fairly, in all material respects, the financial position of Farkas for Calgary Campaign as at July 31, 2025, and the results of its operations in accordance with the LAEA.







1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of presentation

The financial statements were prepared in accordance with the Local Authorities Election Act (LAEA) section 147.3 and 147.4. The statement is defined as a "Campaign Disclosure Statement and Financial Statement".

Revenue Recognition

Campaign contributions are recognized as revenue when cash receipts are received.

Expenditures Recognition

Campaign expenditures are recognized as expenditures when the expense is incurred.

Measurement uncertainty

The preparation of financial statements in conformity with Canadian accounting standards requires management to make estimates and assumptions that affect the reported amount of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the period. Such estimates are periodically reviewed and any adjustments necessary are reported in earnings in the period in which they become known. Actual results could differ from these estimates.

2. FUND-RAISING FUNCTIONS

The Local Authorities Election Act (LAEA) 147.31(3) requires a portion of ticket sales from fund-raising functions to be recorded as contributions. The candidate has opted to use subcaluse (a) to calculate the contribution amount.



The concentration of credit risk from campaign contributions is limited as the organization only recognizes contributions once they are received.

(b) Liquidity risk


