





INDEPENDENT PRACTITIONER'S LIMITED ASSURANCE REPORT ON COMPLIANCE

To the Candidate

We have undertaken a limited assurance engagement of accompanying campaign disclosure statement and financial statement (the "Campaign financial statements") of John Pantazopoulos (the "John Pantazopoulos Campaign") for the period from January 1, 2025 to December 31, 2025, in accordance with Sections 147.3 and 147.4 of the Local Authorities Election Act, Revised Statutes of Alberta 2000 (the "Act").

Candidate's Responsibility

The Candidate is responsible for the John Pantazopoulos Campaign's financial statements compliance with the specified requirements of the Act. The Candidate is also responsible for such internal control as the Candidate determines necessary to enable the Campaign financial statements' compliance with the specified requirements.

Our Responsibility

Our responsibility is to express a reasonable assurance opinion the John Pantazopoulos Campaign's financial statements compliance based on the evidence we have obtained. We conducted our limited assurance engagement in accordance with Canadian Standard on Assurance Engagements 3530, *Attestation Engagements to Report on Compliance*. This standard requires us to conclude whether anything has come to our attention that causes us to believe that he John Pantazopoulos Campaign's statement that the Candidate complied with the specified requirements is not fairly stated, in all material respects.

A limited assurance engagement involves performing procedures (primarily consisting of making inquiries of the Candidate and others within the entity, as appropriate, and applying analytical procedures) and evaluating the evidence obtained. The procedures are selected based on our professional judgment, which includes identifying areas where the risks of material misstatement in the Candidate's statement of the entity's compliance with specified requirements are likely to arise.

The procedures performed in a limited assurance engagement vary in nature and timing from, and are less in extent than for, a reasonable assurance engagement and, consequently, the level of assurance obtained is substantially lower than the assurance that would have been obtained had a reasonable assurance engagement been performed.

Our Independence and Quality Management

We have complied with the relevant rules of professional conduct / code of ethics applicable to the practice of public accounting and related to assurance engagements, issued by various professional accounting bodies, which are founded on fundamental principles of integrity, objectivity, professional competence and due care, confidentiality and professional behaviour.

The firm applies Canadian Standard on Quality Management 1, *Quality Management for Firms that Perform Audits or Reviews of Financial Statements, or Other Assurance or Related Services Engagements*, which requires the firm to design, implement and operate a system of quality management, including policies or procedures regarding compliance with ethical requirements, professional standards and applicable legal and regulatory requirements.
