Independent Practitioner's Review Engagement Report

To the Management of Sonya Sharp Campaign

I have reviewed the accompanying financial information of Sonya Sharp Campaign (the Campaign) that comprise the statement of cash receipts and expenses incurred for the seven month period ended July 31, 2025, and a note describing the basis of accounting.

Management's Responsibility for the Financial Information

Practitioner's Responsibility

A review of financial information in accordance with a basis of accounting for review engagements is a limited assurance engagement. The practitioner performs procedures, primarily consisting of making inquiries of management and others within the entity, as appropriate, and applying analytical procedures, and evaluates the evidence obtained.

The procedures performed in a review are substantially less in extent than, and vary in nature from, those performed in an audit conducted in accordance with a basis of accounting. Accordingly, I do not express an audit opinion on this financial information.

Conclusion

Based on my review, nothing has come to my attention that causes me to believe that the financial information does not present fairly, in all material respects, the financial position of Sonya Sharp Campaign for the period ended July 31, 2025, and the results of its operations and its cash flows for the period then ended in accordance with a basis of accounting described in Note 2.


Basis of Accounting, and Restriction on Distribution and Use



1. Description of business

The campaign was created for the purposes of the mayoral candidacy campaign for the municipal election on October 20, 2025 in Calgary, Alberta. Election campaigns in Alberta are governed by the Local Authorities Election Act (LAEA) and related municipal bylaws.


2. Basis of accounting

3. Additional disclosure

Cash receipts do not include a loan received from Communities First Political Party in the amount of \$21,750.

Unpaid expenses in the amounts of \$21,245 are included in accounts payable and accrued liabilities, but are recognized as an expense incurred in the financial information.
