### **Practitioners' Responsibility**

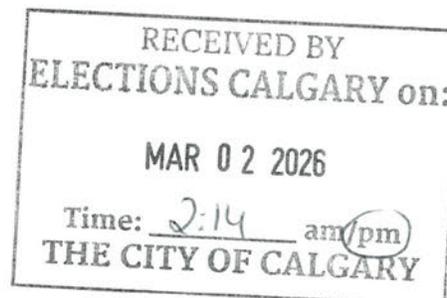

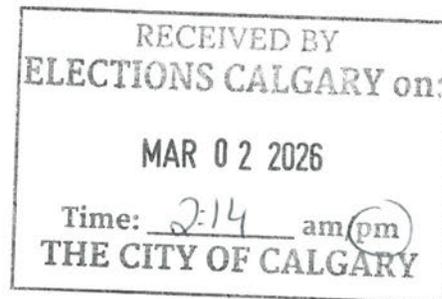
**Basis of Accounting and Restriction on Distribution and Use**

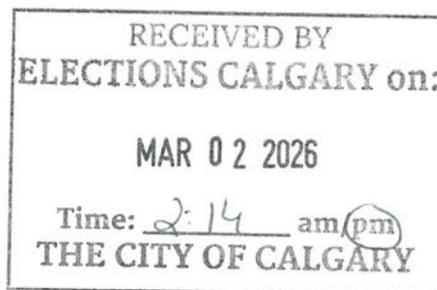

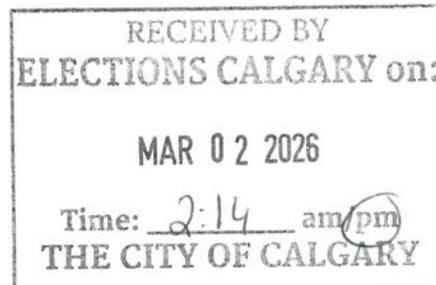

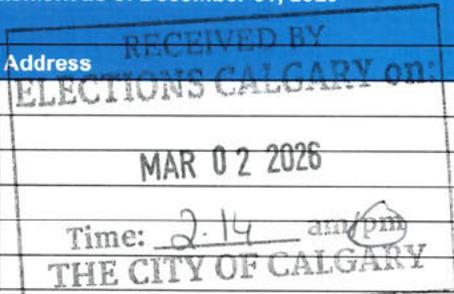
### 2. Basis of Accounting

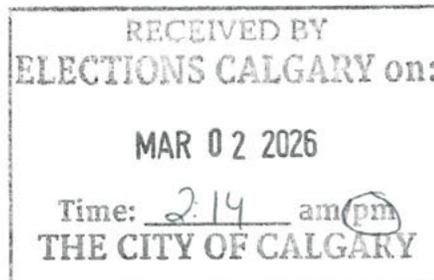

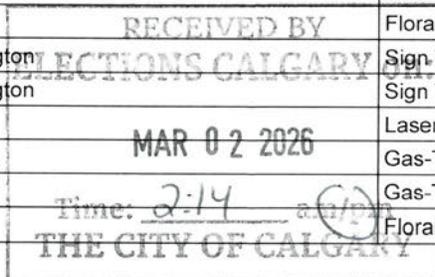
